- 2. Planning, management and training of Group 'A', 'B' & 'C' Telecommunication personnel including cadre control of Group 'B' Telecommunication staff

Commissioner is the administrative head of the Directorate.

Addl. Commissioner, Addl. Director, Deputy Commissioner, Asstt. Commissioner, Asstt. Director and other subordinate staff are responsible for the disposal of government business under their charges.
