Directorate of Logistics proposes for auction of obsolete/old/condemned furniture and other items on "As is where is basis".

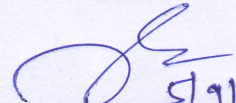

Terms & Conditions

1. The bidders may inspect the items on date and time indicated in the Auction Notice and satisfy themselves about the items they are bidding for.
2. Auction shall be made on "as is where is basis".
3. Auction will be carried out/sold out with full quantity of condemned material and not in pieces. Amount would be quoted for the lot as a whole.
4. No items, once disposed to the highest bidder shall be taken back by the Directorate of Logistics under any circumstance whatsoever.
5. The highest bidder will be required to deposit at least 25% of the bid value on the day of auction by cash or demand draft/pay order drawn in favour of "The Pay & Accounts Officer, CBIC, New Delhi" issued by any Commercial Bank".
6. The highest bidder will make the balance payment of 75% in full, in the form of demand draft/pay order drawn in favour of "The Pay & Accounts Officer, CBIC, New Delhi" issued by any Commercial Bank" by 1700 hrs. on 23rd September, 2019, failing which the offer will be cancelled and 25% of amount deposited shall be stand forfeited.
7. The Highest bidder shall be required to lift all the items from the disposal site within 2 days after the payment of the full amount i.e. by 23rd September, 2019.
8. The highest bidder should ensure himself that the whole auctioned lot is removed and in case any item left at site, the same shall be thrown away at the risk and cost of highest bidder.
9. The labour, cartage and other expenses shall be borne by the highest bidder.
10. The terms & conditions are not exhaustive but general in nature. Directorate of Logistics shall have the right to clarify any clause or part thereof the terms & conditions and what will be final and binding.
11. The highest bidder shall be decided based on total monetary value to items quoted by the bidders in the auction.
