### AUCTION NOTICE

**Auction of old/ obsolete telecommunication stores viz. scrap of HF/VHF wireless sets, test instruments, tools, accessories, spare parts etc.**

#### 1. Scope of work

Directorate of Logistics proposes for the auction of old/ obsolete and un-serviceable telecommunication stores on "as is where is basis" under the following categories:-

#### 2. Terms & Conditions

2.1 The items mentioned above are located at Directorate of Logistics , Indirect Taxes & Customs , DDA Shopping Centre, 7<sup>th</sup> Street, Shantiniketan, New Delhi-110021. The bidders may inspect the items on date and time indicated below and satisfy themselves about all the items before submitting the bid. 2.2 The bidder will quote price separately for each category as per the proforma given below:-

Category	Items	Bid Price in Rs.
Category -I	Scrape of HF/VHF wireless sets	
Category -II	Tools, test instrument, accessories, batteries, power supplies etc.	

2.3 A bidder, if wants, can quote for one or both the categories. However, the auction will be carried out/sold out with full quantity of condemned material category wise. Amount shall be quoted for the each category as a whole.

2.4 All the bids will be received in a sealed envelope at a given date & time above. The bidder, who submits bids for both the categories, should submit the same in separate sealed envelope.

2.5 After opening the bids at a date & time given above, the Price Evaluation will be made separately for each category to ascertain the highest bidder ( H1). Based on the price evaluation, the award shall also be given separately to the highest bidders in each category.

2.6 No items, once disposed to the higher bidder shall be taken back by the Directorate of Logistics under any circumstances whatsoever.

2.7 The highest bidders in both the categories, will be required to deposit at least 25% of the bid value by **1200 hrs on 07-12-2022** (the day of auction), by Demand Draft/Pay order only, issued by any Commercial bank. The DD/Pay order shall be drawn in favour of "The Pay & Accounts officer, CBIC, New Delhi payable at New Delhi". The prospective bidder will be required to produce a copy of identity proof of self/residential address before opening of the bids.

2.8 The highest bidders will make the balance payment of 75%, in the form of Demand Draft/Pay order, issued by any Commercial Bank by **1700 hrs on 08-12-2022**, failing which the offer will be cancelled and 25% of amount deposited shall be stand forfeited. This DD/Pay order shall be drawn in favour of "The Pay & Accounts officer, CBIC, New Delhi payable at New Delhi".

2.9 The highest bidder will be required to lift all the items from the disposal site within **2 days i. e. by 1700 hrs on 09-12-2022**, after the payment of the full amount.

2.10 The highest bidder should ensure that the whole auctioned lot is removed and in case any item left at site, the same shall be thrown away at the risk and cost of highest bidder.

2.11 The labor, cartage and other expenses shall be borne by the highest bidder.

2.12 The terms & conditions are not exhaustive but general in nature. Directorate of Logistics shall have the right to clarify any clause or part thereof the terms & conditions and that will be final and binding.

2.13 The auction can be rescheduled / cancelled at the discretion of the Directorate of logistics.
